6. Access to the club house and electrical power to the slip will be provided upon acceptance of all requirements set forth in this agreement.

This agreement may be terminated at the sole discretion of the BRYC Board of Directors for any infraction of the provisions of this agreement, BRYC Rules and Regulations, state, local or coast guard rules, laws or ordinances. Should the BRYC elect to terminate this agreement the renter shall receive a written notice and shall have ten (10) days from the date on the notice to remove his vessel and any other personal property from the premises. Refund of any rental fees shall be at the sole discretion of the slip owner.
8. Acceptance of this agreement shall also constitute acceptance of the BRYC Rules and Regulations.
